USD #382 PreK Beyond the Bell

Welcome to Patt USD #382's preschool after school program, "Beyond the Bell." Students who are 4 years old on or before August 31st of the current school year, may enroll in PreK Beyond the Bell. Students may attend from 3:00 p.m.- 5:15 p.m., Monday- Friday, when school is in session, with a normal release time of 3:00. Students are given recess, a snack, and quiet free play time. Some days students may do crafts, watch an age appropriate movie, or participate in other enrichment activities. All activities will take place at Southwest Elementary School.

There is a monthly charge for BTB for PreK students, based on free, reduced, or full pay lunch status. Fees will be the same as for BTB in grades K-5 and include discounts for multiple children at Southwest/ PAC. Payments need to be made by the 15th of the month or your child(ren) will not be able to attend until the fee is paid. Statements will be sent by USD #382 Southwest Secretary, Misty Roberts.

Tardiness in picking up students is simply not tolerated, as it involves the necessity of USD #382 to Pay BTB staff additional compensation to remain with the child until a parent (or authorized person) arrives to claim the child. Parents will be held accountable for late pick up.

As habitual tardiness to pick up a child is unacceptable, Beyond the Bell will use the following guidelines to determine continued eligibility for the program:

Accidents

If your child has a wet accident, we will utilize the extra clothes kept in their classroom for the student to change into. If the accident is solid, we have to call a parent to come change or pick up the child. Staff are not allowed to do this.

Behavior and Expectations

All policies and procedures of the Board of Education for USD #382 must be adhered to during all Beyond the Bell program activities.

Beyond the Bell rules are taught in each classroom and are adopted to reinforce positive behaviors in school.

Rule #1- Listen and follow directions guickly

Rule #2- Raise your hand for permission to speak

Rule #3- Respect yourself, respect others, and respect the world around you

Rule #4- Make smart choice

The purpose of the program is to provide a positive learning environment for children. If there is a problem, the following will take place:

- 1.) BTB staff will conference with the student.
- 2.) Time out for the student- will be age/ behavior appropriate
- 3.) An incident report is signed by the parent and kept on file (hitting, biting, kicking, etc.)
- 4.) BTB staff will conference with the parent.

To provide the best learning environment for all the children, repetitive behavioral problems will be addressed as follows:

- 1.) After the receipt of the 5th disciplinary incident report the child will not be allowed to attend the program for the next 5 consecutive school days.
- 2.) If the problem continues, the student may no longer be eligible to participate in the program.
- 3.) Beyond the Bell reserves the right to expel a student from the program who engages in disruptive behavior or behavior that is harmful to himself or others without the necessity of having received 5 disciplinary incident reports.
